

## Definitions

1. In these Terms of Use: "relevant Websites" means this Website or other Websites owned by the Information & eGovernment Authority ("iGA") that are linked from this Website; "use of the datasets" includes accessing, downloading, copying, distribution, transmission, modification and adaptation of the datasets, or any derived analyses or applications, for commercial purposes or otherwise.

## Acceptance of Terms of Use

2. By accessing and using the datasets provided in this Website or other Websites owned by the iGA that are linked from this Website, you shall be deemed to have accepted to be legally bound by these Terms of Use. If you do not agree to these Terms of Use, do not use the Website and the datasets.

3. These Terms of Use may change from time to time without notice. Please check the Terms of Use whenever you access or download the datasets for use.

## Conditions of Use

4. Subject to these Terms of Use, the iGA allows you a royalty-free, non-exclusive use of the datasets for the following purposes: (a) copying, distribution or transmission of the datasets; (b) adaptation of the datasets to suit your needs; (c) use of the datasets for applications that you develop; or (d) sharing or commercialisation of the applications that you develop using the datasets.

5. You must:

(a) clearly state in your applications, research, articles, or websites containing the datasets the source of the datasets and the date the datasets were downloaded from this Website;

(d) include the same requirements stated in paragraphs a, b and c in any sub licences that you grant, require your sub-licensees to do the same; and

(e) cease to use the datasets and remove them from your applications or websites upon the request of the iGA in the event that the datasets are no longer provided on [www.data.gov.bh](http://www.data.gov.bh) or of a breach of any of these Terms of Use.

6. You must not use the data for purposes deemed inappropriate and/or misleading to the general public. Such instances include, but are not limited to:

To the fullest extent permitted by law, the iGA shall not be liable to you or any third party for damage or loss of any kind, including but not limited to direct, indirect, punitive, special or consequential damages, loss of goodwill, loss of business resources, income, revenue or profits, lost or damaged data, or damage to your computer or other property, arising directly or indirectly from your or any third party's use of, or inability to use, the datasets or the relevant Websites.

### **Indemnity**
